

## PRIVACY POLICY

In accordance to the current norms and provisions of the Art. 13 of the EU Regulations 2016/679 of the European Parliament and Council, dated 27 April 2016, related to the protection of natural persons with respect to personal data processing, including the free circulation of those data (from now on "Regulations"), we inform you that the Owner processing the data you provided is the company DALDOSS ELEVETRONIC SPA (from now on DALDOSS) headquartered at Via al Dos de la Roda 18, 38057 Pergine Valsugana, Trento, Italy, VAT code 01654330222.

### Navigation data

The IT systems and programs used for the operation of the site collect some personal data of which the transmission is implicit in the use of Internet communication protocols (such as IP addresses or domain names of the computers used by the users connecting to the site, the URI addresses – Uniform Resource Identifier – of the required resources, time of the request, modality used in channelling the request to the server, dimension of the file obtained as a reply, numerical code about status of the reply provided by the server – completed, error, etc. – as well as other parameters related to the operating system and the IT environment of the user). Even though such information's are not collected to be associated to identified interests, by their own nature they could, by means of elaborations and associations with data retained by third parties, permit identification of the users.

Those data are used solely for the purpose of extracting statistical information not associated to any identity datum of the user on the use of the site and to verify the proper operation and are being erased immediately after processing. The data could be used to ascertain liabilities in case of hypothetical IT crimes against the Site.

### Data provided spontaneously by the user

For site navigation the user does not need to provide any personal data.

However, possible contacts with DALDOSS, or the optional entry, explicit and spontaneous of messages, email or traditional mail, to the DALDOSS addresses indicated in the site, imply the subsequent acquisition of the address, including email, of the sender or of the related telephone numbering, necessary to reply to the inquiries as well as other personal data included in the said communications.

This data will be solely used to follow up to the inquiry of the user and could be forwarded to third parties only and if deemed necessary to do so.

For the data processing for such purpose, your consent isn't needed since processing is necessary for the execution of a contract which includes you or the execution of pre-contractual measures added to your request (art. 6, para 1, let. B) of the Regulations), including, where applicable, complying with a legal requirement (art. 6, para 1, let. a) of the Regulations).

You might require a complete and updated list of the indicated subjects responsible for the processing by contacting one of the listings indicated here below.

The data could be transferred within the European Union, where DALDOSS or its suppliers might be headquartered or where their servers might be placed in such countries. The data will not be released outside the European Union.

You will have the right, at any time, to exercise the rights provided for by the current norms, including the right of:

- receive confirmation of your personal data existence and gain access to its contents
- update, modify and/or correct your personal data
- request their cancellation (oblivion), the conversion in an anonymous form, blocking the handled data infringement or limiting the processing
- oppose yourself for legitimate reasons to the processing
- receive copy of the data you provided and demand that such data will be conveyed to another Owner of the processing
